



SUMMARY OF NAAC REPORT Nov 2015 FOR FUTURE IMPROVEMENTS IN FUNCTIONING OF NEHRU GRAM BHARATI VISHWAVIDYALAYA

1. Language Lab needs to be properly equipped/revamped.
2. Innovative pedagogies like use of ICT is yet to be introduced.
3. Practical Labs & workshop are inadequate for science courses.
4. Student teacher ratio is extremely poor.
5. Research Centre is yet to be equipped for carrying out quality research.
6. Financial support for teachers to attend conferences etc be enhanced.
7. Resource mobilization for research is poor.
8. Inadequate & non functional research labs in some departments.
9. Research journals, to be augmented.
10. MoU's done should have clearly defined objectives, implementation plans.
11. Science faculty has only one departmental Lab.
12. Central library with Library Science Department is yet to be set-up.
13. Journals, digital library and E-resources are yet to be in place.
14. Licensed soft wares are yet to be installed/confirmed.
15. Systematic faculty empowerment strategy is not in place to move up -> HoD/Dean/Dir/BOS/AC.
16. Mechanism for Annual Appraisal System for faculty needs to be introduced.
17. Research incentives are to be devised.
18. IQAC has yet to be effectively functional.
19. Waste management system to be explored for post harvesting/composting.
20. Student chapters of professional bodies are to be started.
21. Course plan and teaching plan design are yet to be introduced.
22. Two campus libraries with total of 27,783 books need to be further Strengthened.
23. Placement cell be established.
24. Labeling of plants & trees in the campus.
25. Erecting of Slogans-boards for promotion of Ethical values throughout the campus.
