The Receiving Party acknowledges that unauthorized disclosure may cause irreparable harm to the Disclosing Party, entitling the Disclosing Party to seek immediate injunctive relief.

The Parties hereby agree to indemnify, reimburse, defend and hold harmless the other Party, its affiliates and other officers, directors, employees, agents, successors and assigns, from and against any and all costs, losses, damages, lawsuits, deficiencies, claims and expenses (including court costs and reasonable attorney's fees) incurred or suffered by the other Party in connection with or arising out of or resulting from or incidental to:

- (a) any breach or obligations, representations and warranties as set out in this MoU; or
- (b) willful default or gross negligence on the part of the other Party during the course of the performance of this MoU.

Dispute Resolution

This MoU shall be governed by and construed and enforced in accordance with the laws and regulations of the Republic of India, excluding its conflict of laws rules to the extent such rules would apply the law of another jurisdiction. All disputes, differences of opinion and controversies arising between the Parties out of this MoU shall be resolved amicably, failing which they shall be finally settled by a sole arbitrator mutually appointed by the Parties herein. The Arbitration shall be conducted in accordance with the Arbitration and Conciliation Act, 1996 or any amendment thereof for the time being in force.

Governing Law

This MoU shall be governed by and construed in accordance with the laws of the Republic of India. The courts in New Delhi shall have exclusive jurisdiction over any disputes arising from this MoU

Amendments

Any amendments or modifications to this MoU must be made in writing and signed by both parties.

Termination

This MoU may be terminated by either party with [X days/weeks/months] written notice to the other party. In the event of termination, both parties agree to fulfill any outstanding commitments made prior to the notice of termination.
