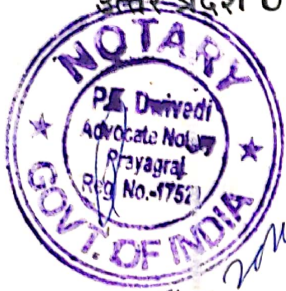

## MEMORANDUM OF UNDERSTANDING (MoU)
